BOOKING CONDITIONS

1. RESERVATION

To reserve one of the Gîtes, the booking form, once duly completed and signed, should be returned together with a cheque for the initial 25 % deposit (non-refundable). Following receipt of the booking form and deposit, a booking confirmation will be sent to you.

2. PAYMENT OF BALANCE

The balance of the rent together with the security deposit (refundable) is payable **6 weeks** before your holiday commences. If payment is not received by the due date, we reserve the right to cancel your booking. No invoice will be sent.

3. SECURITY DEPOSIT

A security deposit of £ 100 is required to cover all breakages, damages, losses and additional cleaning (if necessary). After the gîte has been checked the deposit or residue of it will be returned within 2 weeks.

4. TRAVEL INSURANCE

You are advised to arrange a comprehensive travel insurance policy (including cancellation cover), and to have full cover for the party's personal belongings, public liability etc. since these are not covered by the owners insurance.

5. LETTING PERIOD

The letting period commences at 4.00 pm on Saturday and finishes at 10.00 am on the last Saturday.

6. OCCUPANCY NUMBERS

The maximum number of people to reside in the property must not exceed that stated on the booking form.

7. LIABILITY

We shall not be liable:

For any temporary defect or stoppage in the supply of public services to TOULAMBIC

for any loss, damage or injury which is the result of adverse weather conditions, or other matters beyond our control.

for any loss, damage or inconvenience caused to or suffered by the Client if TOULAMBIC should be destroyed or substantially damaged before the start of the holiday period and in any such event, we shall, within 7 days of notification to the Client, refund to the Client all sums previously paid in respect of the letting period.
